The '12 Module – 2 Small Drawers and 1 Large Drawer 420w x 465d with Castors and Skid' submitted for testing, has satisfied the relevant requirements of BS 4875: Part 8: 1998'Non-Domestic Furniture – Storage – Methods for determination of Stability'. The '12 Module – 2 Small Drawers and 1 Large Drawer 420w x 465d with Castors and Skid' submitted for testing, has satisfied the relevant requirements of BS EN 14073-2: 2004 (Office furniture. Storage furniture. Storage furniture. Test methods for the determination of stability and strength of the structure) and BS EN 14074: 2004 (Office furniture. Tables and desks and storage furniture. Test methods for the determination of strength and durability of moving parts).

As the '12 Module – 2 Small Drawers and 1 Large Drawer 420w x 465d with Castors and Skid' submitted for testing is representative of the whole range of the same construction, based on the evidence supplied by Bisley Office Furniture. SATRA would also consider the '12 Module – 2 Small Drawers and 1 Large Drawer with Levellers 300mm x 465mm' to also meet the relevant strength requirements of BS 4875: Part 8: 1998 and BS EN 14073-2: 2004 and BS EN 14073-3: 2004 and BS EN 14074: 2004 and also, BS 4875: Part 7: 2006 'Test Level 4 - General Domestic / Contract' with the exception of Clauses 7.5.2 and 7.5.4. (Any changes to the range will invalidate the certificate). Based on the evidence supplied by Bisley Office Furniture. SATRA would also consider the "Note" and the "Wave" range of items to be covered by this report with respect to the tests carried out. (Note added on 4<sup>th</sup> April 2007/JMS).
